Florida Atlantic and Nevada with interest rising. In an RNG exclusive interview, I sat down with the Southern California native learning more about his growing skillset with an overview on his recruiting opportunities.

Interview:

Julian, you've been a consistent presence in the backfield for Upland over the past two seasons. During the 2019 campaign, how did you see your talents as a ball carrier improve?

"My carrying and vision improved a lot, to be honest. My sophomore year opened my eyes that it is a different game at the varsity level; the game speed and the up-tempo pace, that helped me adjust. My blocking improved a lot this past season. Over the offseason I hit the weight room, I got stronger."

What were some of the designed plays called putting the ball in your hands?

"It was more inside zone, reading my blocks and go. I did some outside runs, but not too much. I was getting some screen passes. Not too many tosses, I was going mostly up the gut."

Which game last season was your best game?

"My best game was against Crenshaw, that was my best. I was fully healthy. I went for over 170 yards with two touchdowns, I'm not sure how many carries I had. That was my breakout game."

Where all might we see you on the field during your senior season?

"Running back for sure. I am trying to play defense; I don't care where. I want to play special teams. I want to play all over the field to show my versatility. Where I play, it is up to my coaches."

With offseason workouts in full-swing, what are you working on with your game?

"I'm working on speed and stopping and going. I am doing track currently. I am working on my speed, form, and my breakaway speed. I'm working on my cuts and my reads."

Do you know which track events you will compete in this spring?

"I'm not sure yet. We've been practicing, I might do the 100. I don't know."

This spring, are you going to any camps?

"Yes. I am going to the UA (Under Armour) camp on Feb. 9, and I might be going to a Rivals camp."

Are you playing 7v7 this spring as well? If so, which team are you playing for?

"Ground Zero."

In recruiting. Which schools are showing interest?

"UNLV, they've been heavy. I've received letters from others, but not as consistent as UNLV."

I know you've received a couple of offers, which schools have offered?

"Florida Atlantic and Nevada."

Have you taken any unofficial visits over the last few months?

"Yes. I went to Miami, Arizona State, and FAU."

How did the FAU visit go?

"It went well. I like the school a lot. It is big. Their weight room program is elite. I feel like the coaches, they were very welcoming."

And the ASU visit, how did that go?

"That went well also. I tried on the jersey and took a tour. I saw all the greats that came out of the school. The coaches are down to earth too. Hopefully I can get back soon."

Julian, thanks for your time today and good luck with the upcoming camps and workous.

REWARD OFFERED

By the Governor for the Arrest of Mrs. Lee Stanley's Assailant

Tom Deadman Arrested on the Charge of Being the Guilty Man, Trial Friday

Today, County Judge Tully received notice from Frankfort that Gov. Bradley had offered a reward of \$250 for the arrest of the man who assaulted Mrs. Lee Stanley last week. This, with the reward offered by Mr. Potter and others, makes the amount over \$500.

Saturday night, Constables Hunt and Fortson, of the southern part of the county, brought in Tom Deadman, a man, well known to the county officers. He was arrested below Woodsville, and filled the bill with the exception that he had no beard. He denies having been in the county for a month past, although he formerly worked for Mr. Adams, on a farm only a few miles from Mr. Stanley's. There is doubt as to Deadman's guilt, although many believe he is the man. Others believe if what is said of the man under arrest at Paris, Tenn., be true, and it can be shown that he was in this section on a bicycle that he is the man, as he suits the description so well.

Mrs. Stanley is improving, but is not thought she will be able to attend the trial of Deadman, which is set for Friday. Deadman was kept under an extra guard at the jail Saturday night, but he is in no danger, and seems entirely at ease.

This morning a Ballard county man appeared and went on Deadman's bond for \$500. The old man, ie understood, (sic) claims the accused was working for him on last Monday, the day of the assault on Mrs. Stanley. He said he would go on his bond for \$5,000 if necessary. Judge Tully took the bond. No one has yet gone down to Paris to identify the man in their jail.

DEADMAN OUT AGAIN

A Muderer From McCracken Confesses to the Crime

The Innocent Prisoner Has Been in the Eddyville Penitentiary For Three Years

WAS QUITE AN INTERESTING CASE

Tom Deadman, a man who for years was a respected resident of the Maxon's Mills section of the county, is a free man again, after serving three years in the Eddyville penitentiary for a crime he never committed. His case presents a peculiar miscarriage of justice.

Over three years ago Mrs. L. Stanley of the city, a daughter of Councilman Joe Potter, who then resided about five miles from the city, was assaulted by a man, who called when she was alone and asked for something to eat. His object was robbery, and he shot her in the head and made his escape, after failing to get anything. Mrs. Stanley, fortunately, was not seriously injured, but the dastardly assault created the wildest excitement, and posses scoured the the country for several days in every direction in their effort to get some trace of the criminal.

Tom Deadman, a man fourty years of age or older, was finally arrested, and lynching was narrowly averted. He protested his innocence. In circuit court he proved a complete alibi, but all his witnesses were friends, and the jury discredited their statements, and gave Deadman five years, the full penalty, for malicious assault.

About two years ago Ed Capps of Metropolis, IL, an employee of the Leyhe fleet above Paducah, was murdered and robbed, and his body thrown into the river, while he was being rowed to the fleet by John David, alias Hawkins. Hawkins was afterwards arrested and brought here and tried, being given a life sentence. It was suspected at the time, from his testimony that he was Mrs. Stanley's assailant, and Commonwealth's Attorney Bradshaw, who was never satisfied of Deadman's guilt, was convinced that Hawkins was the man.

He would never make a confession, however, until a short time since, and when he did confess to having shot Mrs. Stanley, application was made to Governor Beckham for a pardon, the facts being outlined, and Sunday afternoon it was issued, and Deadman was released today.

Judge James Campbell, who was Deadman's attorney, stated this morning that there is absolutely no redress for his former client, who has had to remain in prison three years, and the state has had his services at hard labor for that length of time without having to pay him a cent.

My mother always sewed my Easter dresses. This was done the Saturday before Easter. There were times I tried on these to be sure they fitted properly. When Mother was satisfied with the results, I could go to bed. She stayed up and finished the garment which was ready for Easter. When I was about twelve there were no preparations for a dress. But she asked me to go to the Drug Store to pick up my dress. I certainly knew they did not have dresses at the Drug Store but it never occurred to me to ask for an explanation – I just went. The surprise came when I was handed a tennis racket. We had new tennis courts at the school and this was where I learned how to play this sport. Someone no doubt gave us the general rules of the game but there was no instructor after that, just kids playing most of the time when school was not in session. This was where I learned to play tennis and I continued playing thru college.

We had no family car until I was a senior in High School. During the previous years, we walked to town, to church and to school. These locations were no farther than three or four blocks. There were other people going the same way at the same time so we always had company.

My grandmother offered me my very first job. My age was probably about four and she offered to pay me one cent for each kitchen chair that I washed. Over a period of time I managed to wash five chairs and she brought me my five cents. I was so pleased with my fortune. Then she explained that I should give this money to the women's group at church.

My paternal grandfather took me to town with him one day and gave me five cents to spend. This was immediately turned into a sack of candy. The candy was bulk candy and so you could choose pieces of several kinds. This does not seem so special until you realize a loaf of bread cost five cents at that time.

When I was still young enough to stand in the back seat of a car (no car seats, of course) my parents and grandparents went on a trip to see my aunt. The car was a Model A sedan, several years old, I am sure. My father was the driver and I can remember there were many hills that I wondered if the car would even make it to the top. Have no idea of the time this trip would take, but considering the speed of the vehicle, the roads, and the distance, it was probably an all day trip.
