SGT DEDMAN IS HOME; WOUNDED TWICE IN FRANCE

Sergeant Sam Dedman, son of Mr. and Mrs. J.D. Dedman who fought through several campaigns in France with the Rainbow Division as a member of the famous 151st Machine Gun Battalion, along with several other Americus men, returned home Sunday after being mustered out at Camp Gordon Friday.

"Glad to be back is the right word," said Sergeant Dedman. "I've had enough for the rest of my life. Here -after when I find a fellow that wants to fight, I'll tell him to find somewhere else. Me for the quiet, peaceful life from now on."

Sergeant Dedman surprised his parents by informing them that he was wounded twice in France, he not having told them of it in any of his letters, and they never having been notified through the war department. He was wounded in the thigh by shrapnel August 2, and in the leg by a serial bomb on Oct. 21. Both wounds put him in the hospital for several weeks, and he was in a rest camp when the armistice was signed.

Sergeant Dedman was in the front line trenches within four days after reaching France. When his battalion sailed from New York in Oct.1917, he was ill and remained in a hospital near New York for several months. When he finally sailed the Rainbow division was in the thick of the fighting, and he was hurried into the trenches on arrival.

"An order of the German crown prince was all that kept the Germans from breaking completely through at Chateau Thierry," he said. "When the Germans attacked, they crashed right through, but after making a certain gain the crown prince ordered them to wait for him to come up with his forces. It took him three days to arrive, and by that time we were reinforced and that ended the German advance and the tide was turned right there.

"But they gave us plenty, and our losses were very heavy. The Rainbow division has been shot all to pieces. Now there is probably not one man in a hundred left in it who was a member of the division when they first went in."

The Eighty-Second division suffered heavily in the Argonne forest. They were right near where I was in the hospital when they started. When they came out eight days later they had lost about three-fourths of their men."

Sergeant Dedman declares the treatment the men received and the hardships they suffered in their camps after the signing of the armistice were inexcusably bad. "For months we were quartered in sheds," he said, "that leaked and had no floors. The rains fell in torrents and ran into the sheds. We had wire net springs, strung on 2x4 pieces, laid on the ground. We had one blanket under us and two or three for covers. It was cold, there being snow on the ground nearly the whole time. And we nearly without fuel nearly the whole time; none was provided us except toward the last a little, and we were not allowed to go about the country to find wood to burn. At best conditions were very bad. Inspections were made, but the inspectors always telephoned ahead when they were coming, and the officers had the camps slicked up and looking fine when they arrived."

Sergeant Dedman came home as a casual, not being with his unit at the end of the war, and not having gone into Germany with the Army of Occupations. "There were a lot of us in the rest camp in January." he said, "who were asked whether we wanted to rejoin our outfits or be sent home. Things had been mighty uncomfortable and every man said 'home' without a moments hesitation. It took us nearly two months to get to sail, but we did better than many who have been waiting for a long time to return."

He first went into the military service as a member of the Americus Light Infantry and was alter transferred to the "Rainbow" division. Recently he had been postmaster at Camp Merritt, whence he sailed for overseas duty. The trip across, according to a message from him, was made in twelve days, and was without incident.

The following article is from a cousin, Alleen Cater, who has spent a lot of time in search for answers to some of our ancestors. I have exausted my resources along with her diligent efforts and decided to reach out to our resourceful readers, hoping someone has some helpful information to provide some of the missing "bricks" in our wall. I have been searching far and wide for primary documents pertaining to William Howard Dedman (1803-1846), his wife, Elizabeth Haile (1806-) and their daughter, Eleanor Elizabeth Dedman Williams (1828-1850). Bible records would be particularly helpful. Perhaps someone has a record, a letter, a Will or a connection which I have not seen. James M. Dedman, III, who is my fourth cousin, has taken great interest in this project and has made many helpful suggestions. He has encouraged me to reach out to this group.

In a Williamsport, TN cemetery, two time-worn, onceidentical stone shafts mark the graves of the first two wives of Edward Williams, II (1820-1890) of Williamsport, and later of Columbia, both places being in Maury County. Dorothy Darby Williams (1820-1843) died one month after the birth of her first child, Thomas. Following Dorothy's death, in 1845 Edward married Eleanor Elizabeth Dedman (1828-1850). Eleanor bore a son, William Howard, in 1846; a daughter, Elizabeth, in 1848; and a son, Edward, in April, 1850. Eleanor died April 23, 1850, either in or very shortly after childbirth. The Sept. 7, 1850 Maury County, TN Census lists Edward Williams with four named children: Thomas, age 6, (my great-grandfather), William, age 4 (also my great-grandfather), Elizabeth, age 2, and an infant, Edward, 4/12 year of age. That child Edward is not listed in the 1860 Census, so he must have died young. I have found no information on his death or burial, which would probably have been in Williamsport, near his mother.

Wanda Williams Colvin's book, The Dedman Genealogy mentions Eleanor at the top of page 48, but the death date is erroneously listed as 1849. The Colvin book lists Eleanor as a daughter of William Howard Dedman (1803-1846) and his wife, Elizabeth Haile. I have no primary record of that parent-child relationship. W. H. Dedman is listed on p.42 in the Colvin book as a son of John Dedman (1776-1835) and Carrie Elizabeth White (?-?). I do have John Dedman's Will, which mentions William Howard several times.

It is known that William Howard and one of his brothers left Mecklenburg Co, VA with their families circa 1830 and went to Hickman Co, TN, where he managed the Bon Aqua Springs Hotel for a few years. Jim Dedman, III has a great map showing where the Dedman families lived when they came to TN from VA. A Find-a-Grave entry shows that WH was buried in Williamsport, but I have found no proof of that. Edward Williams was named Administrator of W.H. Dedman's estate, according to lengthy records in the Maury County Archives; but nowhere is it said that Edward Williams was WH Dedman's son-in-law. The same court papers list Elizabeth Dedman as the widow of WH Dedman; she is not to be confused with her daughter, of course. Another Find-a-Grave record shows that Elizabeth Haile Dedman died years later in Selma, AL. Again, I have no proof of this. Lately it has been suggested that perhaps she remarried, which would make locating her more difficult.

Annie Laura (Deadmon) Griffith's book, DEDMAN - DEADMON Family History states that Wm Howard died 2 Sept 1846 in Williamsport. No proof is cited. Her book contains the same erroneous death date of 1849 for Eleanor.

I have searched microfilm records of St. Mark's Episcopal Church in Williamsport, which was built on land donated by Edward's father, also named Edward Williams, founder of Williamsport. I have consulted Maury County Archives and TSLA. I have searched Newspapers.com. I have searched Early TN Marriages, which lists Edward Williams' marriages, but not that one (he married four times). reviewed the list of services conducted, written inside the back cover of the Bible of The Rev. John B. Hamilton, whose wife Sarah Alderson was an older half-sister of Edward Williams, II. The very helpful Administrator of the church adjoining the cemetery where Eleanor Williams is buried could find no other records. The Administrator told me that the cemetery is owned by the municipality of Williamsport, not by the church. I have not been able to speak with any town official in Williamsport, who could check old records. The Hickman County Courthouse burned in 1863, so any marriage or death records there were lost. I have no idea if Eleanor married Edward Williams in a church or if a priest performed the ceremony.

Are William Howard Dedman and/or Eleanor Elizabeth Dedman Williams mentioned in Bible records?

Is there a marriage record for Eleanor Dedman and Edward Williams?

Is there any record of the birth and/or Baptism of Eleanor's children: William Howard, Elizabeth and Edward?

Is there a record of the death of the baby Edward Williams (1850-)?

Is there a death record for William Howard Dedman or for his wife, Elizabeth Haile Dedman?

Is there hard evidence of a burial place for William Howard Dedman or for Elizabeth Haile Dedman?

I do have extensive information on: William Howard Williams (1846-1908), who married Mary Elizabeth Sarven of Columbia, and is buried in Elmwood Cemetery, Birmingham, AL; Elizabeth/Lizzie Williams Glasgow (1848-1921), buried in Mt. Olivet Cemetery, Nashville, TN; and Thomas Hamilton Williams (1843-1922), who married Annie Caroline White of Spring Hill, TN, and is buried in Rose Hill Cemetery, Columbia, TN. Another Elizabeth Williams is buried in the Williamsport Cemetery: she was the wife of Edward Williams, I and mother of Edward, II; and mother-in-law of Eleanor E Dedman Williams. She died in 1840.

PERSON FOUND DEAD AFTER ROWAN COUNTY HOME DESTROYED IN FIRE



ROWAN COUNTY, N.C. (WBTV) - A person was found dead after a house appeared to be completely destroyed by a fire Thursday afternoon in Rowan County.

The fire occurred around 2 p.m. at a home on Crestwood Drive in China Grove. The single wide mobile home was located at the end of the road.

"Once the fire was extinguished, one victim was recovered from the structure and sadly was pronounced dead on the scene," said Daniel Jenkins of Enochville Fire & Rescue. "We extend our deepest condolences to the affected family.

"The victim has now been identified as **Deborah Renee Deadmon**, 66. According to the Rowan Sheriff's Office, the victim had significant health issues, and did use bottled oxygen.

"There has been no evidence of foul play found at present, nor is foul play suspected," said Captain John Sifford.

WILBURN "WIB" WIMPY



Hal was reared in the Ross Grove community and attended Ross Grove School. He graduated from Fallston High school in 1939 and attended Boiling Springs Jr. College (now Gardner-Webb University) until he was inducted into the 416th Bomb Group, 9th Division of the US Air Force in 1942. His group loaded bombs onto the airplanes and were stationed in England, France, and

Germany during his military tenure. Hal was discharged in 1949 and returned to Shelby where he married Sarah Caroline Blanton of Lattimore. He continued his education at Howard's Business College.

Happy Hal was involved in athletics throughout his life. He played professional baseball with the Boston Braves, the Shelby Farmers, the High Point Hi Toms, and the Rutherford County Owls. He was assistant coach with "Pop" Simmons for the American Legion baseball team (1954-55) and coached the KM Legion team in 1955. In that same year, Hal took the Athletic Director's position at the Shelby City Park, doing the things he loved most.

He developed and coached programs for children and adults as well. He started the Early Morning Milers adult exercise program and a fitness program for ladies. He was in charge of football, basketball, and baseball programs for the local youths. He started a group of Golden Gloves boxing and was Director of the Shelby Boys Club. One of his greatest joys was working with young people. Hal left the City Park in 1967 to take a position with the NC Probation and Parole Department in Western North Carolina and retired in 1985.

Besides his love of baseball, Hal was also an avid golfer. He had 5 holes-in-one and played golf every chance he got. He was a regular at the Royster Golf Course. His nickname "Happy Hal" came from that ever present smile that he gave to everyone. He always just seemed to be naturally happy.

Hal loved being a part of and serving his community. He was a member of the Shelby Lions Club and was awarded the Melvin Jones Fellows award by Lions International in 2002-2003. He was a member of the VFW, DAV, the Lattimore Historical Society, Cleveland County Sr. Golf Association, Fellowship of Christian Athletes, NC Sheriff's Association.

He was recognized as the Director of Outstanding Service to the Youth of Shelby and Cleveland Co. in1965 by the Parks and Recreation Commission. In 1993 he was inducted into the Cleveland County Sports Hall of Fame. The circle around the ball fields at the City Park was named "Happy Hal Circle" in his honor.

Hal's greatest love though was for his family and his church. He was a lifelong member at Ross Grove Baptist Church where at age 12 he earned \$0.25 per week for cleaning the church and ringing the bell. He later served the church as Deacon, Church Clerk, Cemetery Committee Chairman, Building Committee Chairman, Sunday School Director, and served on various committees. He started the Royal Ambassadors group at Ross Grove.
